## EFFECTIVE JUNE 1, 2024 – HW INCREASE

**RE: Eighth District Electric Benefit Fund; Health and Welfare Contribution Rate Increase  
Effective June 1, 2024**

Dear Employer,

This important notice is announcing a **change in your Active Plan, Health and Welfare contribution rate effective with June 2024 work hours**. As a Signatory Employer you must remit on behalf of all staff participating in the Eighth District Electrical Benefit Fund (the “Plan”).

The Trustees have enacted an increase in the hourly Active Plan Health and Welfare contribution rate, which becomes effective June 1, 2024, effectively increasing the hourly and monthly (Non-Bargaining) Health rates. This increase should be used while reporting any June 2024 work due on or before July 15<sup>th</sup>, 2024.
