

U.A. Locals No. 375 and 367 Supplemental Pension Trust

SUMMARY ANNUAL REPORT

This is a summary of the annual report for the U.A. LOCALS NO. 375 AND 367 SUPPLEMENTAL PENSION TRUST, EIN 92-0150923, Plan No. 001, for period January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$7,495,114. These expenses included \$376,669 in administrative expenses and \$7,118,445 in benefits paid to participants and beneficiaries. A total of 2,375 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$102,383,836 as of December 31, 2024, compared to \$92,367,363 as of January 1, 2024. During the plan year the plan experienced an increase in its net assets of \$10,016,473. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$17,511,587 including employer contributions of \$2,185,906, employee contributions of \$2,039,300, net investment gain of \$13,273,543 and other income of \$12,838.
