

DEPENDENT AUDIT IS COMING!

The Fund will soon conduct a dependent-eligibility verification audit to confirm that all dependents who are currently covered under the Plan are still eligible for benefits. The audit will help ensure that the Fund is not paying medical claims for dependents who no longer meet eligibility requirements, thereby reducing unnecessary health care expenses. This helps the Fund save money, so it can continue to provide health benefits for participants and their eligible dependents now and in the future.
