

**AMENDMENT 4 TO THE JUNE 1, 2015
RESTATEMENT OF THE PLAN DOCUMENT
OF THE ARIZONA PIPE TRADES
DEFINED CONTRIBUTION PLAN**

Effective March 1, 2018, the Trustees hereby amend the Plan as follows:


Article III-B, Section 3(c) is restated to read as follows:

Section 3 Method of Allocation

(c) The administrative office of the Pension Fund shall determine the amount of Excess Contributions, if any, for each Participant and shall transfer such Contributions and earnings to the DC Fund. During the period beginning on January 1, 2016 and ending on February 28, 2017, such determination and transfer of Contributions and earnings shall be done twice per year. During the period on and after March 1, 2018, such determination and transfer of Contributions shall be done each calendar month.
