## SUMMARY ANNUAL REPORT

### FOR NORTHERN CALIFORNIA TILE INDUSTRY VACATION AND HOLIDAY TRUST FUND

This is a summary of the annual report of the Northern California Tile Industry Vacation and Holiday Trust Fund, E.I.N. 80-0560254, Plan No. 501, for the year ended December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$94,147 as of December 31, 2024 compared to \$78,623 as of January 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$15,524. During the plan year, the plan had total income of \$1,438,663 including employer contributions of \$1,438,300 and earnings from investments of \$363.

Plan expenses were \$1,423,139. These expenses included \$40,684 in administrative expenses and \$1,382,455 in benefits paid to or for participants and beneficiaries.
