SUMMARY ANNUAL REPORT FOR CENTRAL MIDWEST REGIONAL COUNCIL OF CARPENTERS WELFARE FUND

This is a summary of the annual report for Central Midwest Regional Council of Carpenters Welfare Fund, EIN 45-0593187, for the year ended April 30, 2025. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Trustees of Central Midwest Regional Council of Carpenters Welfare Fund have committed themselves to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has a contract with Union Labor Life Insurance Company to pay life insurance and accidental death and dismemberment benefits incurred under the terms of the plan. The total premiums paid for the policy year ending January 31, 2025 were \$692,022.

The plan also has a contract with Union Labor Life Insurance Company to pay stop loss claims incurred under the terms of the plan for participants. The total premiums paid for the policy year ending July 31, 2024 were \$1,316,665.

The plan also has a contract with Humana to pay Medicare retiree medical and prescription drug benefits incurred under the terms of the plan. Total premiums paid for the policy year ending April 30, 2025 were \$1,362,536.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$517,678,917 as of April 30, 2025 compared to \$150,943,536 as of May 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$366,735,381, which included a transfer of net assets of \$371,500,333 as a result of a merger. This increase also includes realized and unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$261,107,292, including employer contributions of \$218,085,662, participant contributions of \$26,391,038, realized gains of \$687,400 from the sale of assets, and earnings from investments of \$15,943,192.

Plan expenses were \$265,872,244. These expenses included \$4,678,047 in administrative expenses and \$261,194,197 in benefits paid to participants and beneficiaries.

transactions in excess of 5 percent of plan assets.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 700 Tower Drive, Suite 300, Troy, MI 48098, and the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs. Paperwork Reduction Act Statement
