Important Notice About Your Prescription Drug Coverage and Medicare

Please read this notice carefully and keep it where you can find it. This notice has information about your current prescription drug coverage with the Hagerstown Teamsters & Motor Carriers Health & Welfare Fund and prescription drug coverage available for people with Medicare. It also explains the options you have under the Medicare prescription drug coverage and can help you decide whether or not you want to enroll. At the end of this notice is information about where you can get help to make decisions about your prescription drug coverage.

There are two important things you need to know about your current coverage and Medicare's prescription drug coverage:

- 1. Medicare prescription drug coverage became available in 2006 to everyone with Medicare through Medicare prescription drug plans and Medicare Advantage Plans that offer prescription drug coverage. All Medicare prescription drug plans provide at least a standard level of coverage set by Medicare. Some plans may also offer more coverage for a higher monthly premium.**
- 2. The Hagerstown Teamsters & Motor Carriers Health & Welfare Fund has determined that the prescription drug coverage offered by the Hagerstown Teamsters & Motor Carriers Health & Welfare Fund is, on average for all plan participants, expected to pay out as much as the standard Medicare prescription drug coverage will pay and is considered Creditable Coverage.**

Because your existing coverage is on average at least as good as standard Medicare prescription drug coverage, you can keep this coverage and not pay a higher premium (a penalty) if you later decide to enroll in a Medicare prescription drug plan.

Individuals can enroll in a Medicare prescription drug plan when they first become eligible for Medicare and each year from October 15th through December 7th. However, if you lose your current creditable prescription drug coverage through no fault of your own, you will also be eligible for a two (2) month Special Enrollment Period ("SEP") to join a Medicare drug plan.

If you choose to enroll in Medicare Part D at this time and keep your Hagerstown Teamsters & Motor Carriers Health & Welfare Fund prescription drug coverage, your

coverage will be coordinated with Medicare Part D in accordance with the Medicare coordination of benefit rules. Generally, if you are an active employee or the dependent of an active employee, your coverage through the Hagerstown Teamsters & Motor Carriers Health & Welfare Fund will be primary and Medicare will be secondary. Also, your Hagerstown Teamsters & Motor Carriers Health & Welfare Fund coverage pays for other health expenses, in addition to prescription drugs, and you will still be able to receive all of your health and prescription drug benefits if you choose to enroll in the Medicare Part D prescription drug plan. Each individual case is different, but in most cases it will not be cost effective to enroll in Medicare Part D while you have coverage through the Hagerstown Teamsters & Motor Carriers Health & Welfare Fund. However, the decision is yours. You should compare your current coverage, including which drugs are covered, with the coverage and cost of the plans offering Medicare prescription drug coverage in your area.

If you do decide to enroll in a Medicare prescription drug plan and drop your Hagerstown Teamsters & Motor Carriers Health & Welfare Fund prescription drug coverage, be aware that you and your dependents may not be able to get this coverage back.

Please contact us for more information about what happens to your coverage if you enroll in a Medicare prescription drug plan.

You should also know that if you drop or lose your coverage with Hagerstown Teamsters & Motor Carriers Health & Welfare Fund and don't enroll in Medicare prescription drug coverage after your current coverage ends, you may pay more (a penalty) to enroll in Medicare prescription drug coverage later.

If you go 63 days or longer without creditable prescription drug coverage that's at least as good as Medicare's prescription drug coverage, your monthly premium will go up at least 1% per month for every month that you did not have that coverage. For example, if you go nineteen months without coverage, your premium will always be at least 19% higher than what many other people pay. You'll have to pay this higher premium as long as you have Medicare prescription drug coverage. In addition, you may have to wait until the following October to enroll.

Remember: Keep this Creditable Coverage notice. If you enroll in one of the Medicare drug plans, you may be required to provide a copy of this notice when you join to show that you are not required to pay a higher premium amount (a penalty).
