In accordance with Section 404(C) of the Employee Retirement Income Security Act, you have the responsibility to direct the investment of your individual account balance in the Plan. The investment choices, selected by the plan sponsor, are designed to address conservative, moderate, or aggressive investment strategies.

FUND NAME	OBJECTIVE AND ASSET CLASS
Comerica Short Term	Seeks to generate as high a level of current income with maintaining liquidity and stability of principal: Cash
Dodge & Cox Fixed Income	Seeks high and stable rate of current income consistent with long-term preservation of capital: Fixed Income Includes investment in AFL-CIO Housing Investment Trust Fund ("HIT Fund") which primarily invests in multifamily and single family mortgage-backed securities and mortgage backed obligations. This investment constitutes approximately 2% of the Dodge & Cox Fixed Income investment (as of December 31, 2009).
Dodge & Cox Balanced	Seeks regular income, conservation of principal, and an opportunity for long-term growth of principal and income: U.S. Stock & Fixed Income Includes investment in the HIT Fund and AFL-CIO Building Investment Trust Fund ("BIT Fund"). The BIT Fund invests in equity real estate to generate competitive income and long-term capital appreciation. Assets in the HIT Fund represent approximately 3% and the BIT Fund represent approximately 2% of the Dodge & Cox Balanced investment option. (as of December 31, 2009).
Dodge & Cox Equity	Seeks long-term growth of principal and income: Stock
Dodge & Cox Global	Seeks long-term growth of principal and income: U.S. & Non-U.S. Stock
Dodge & Cox International	Seeks long-term growth of principal and income: Non-U.S. Stock
