SUMMARY ANNUAL REPORT

FOR IBEW LOCAL 595 HEALTH & WELFARE TRUST

This is a summary of the annual report of the IBEW Local 595 Health & Welfare Trust, E.I.N. 94-6085740, Plan No. 501, for the year ended January 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Delta Dental of California, Vision Service Plan, Kaiser Foundation Health Plan Inc., UnitedHealthCare Insurance Company, HCC Life Insurance Company, and U.S. Behavioral Health Plan of California DBA Optum to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended January 31, 2021 was \$35,425,551.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ended January 31, 2021, the premiums paid under such "experience-rated" contracts were \$3,534,386 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$2,167,786.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$50,798,227 as of January 31, 2021, compared to \$45,913,423 as of February 1, 2020. During the plan year, the plan experienced an increase in its net assets of \$4,884,804. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$45,522,626 including employer contributions of \$40,347,642, participant contributions of \$2,288,186, earnings from investments of \$2,717,535, and other income of \$169,263.

Plan expenses were \$40,637,822. These expenses included \$1,347,833 in administrative expenses and \$39,289,989 in benefits paid to or for participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
