This is a summary of the annual report for IRONWORKERS INTERMOUNTAIN HEALTH & WELFARE TRUST, EIN 87-6123188, Plan Number 501, for the period November 1, 2023 to October 31, 2024. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The total premiums paid for the plan year ending October 31, 2024 were \$0.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$34,566,345 as of October 31, 2024, compared to \$28,308,368 as of November 1, 2023. During the plan year the plan experienced a change in its net assets of \$6,257,977. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$27,158,476 which included employer contributions of \$21,625,189, employee contributions of \$620,094, other contributions of \$0, gain/loss of \$0 from the sale of assets, and earnings from investments of \$4,913,193.

Total plan expenses were \$20,900,499. These expenses included \$1,696,250 in administrative expenses and \$19,204,249 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
