### **SUMMARY ANNUAL REPORT WELFARE FUND OF ENGINEERS LOCAL 513**

This is a summary of the annual report for the WELFARE FUND OF ENGINEERS LOCAL 513, Employer Identification No. 43-6071748, Plan No. 501, for the period May 1, 2022 to April 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **BASIC FINANCIAL STATEMENT**

The value of plan assets, after subtracting liabilities of the plan, was \$117,913,224 as of April 30, 2023, compared to \$111,668,071 as of May 1, 2022. During the plan year the plan experienced an increase in its net assets of \$6,245,153. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$62,122,751. This income included employer contributions of \$50,891,476, employee contributions of \$6,300,875, realized gains of \$922,470, from the sale of assets and earnings from investments of \$694,847. Plan expenses were \$55,877,598. These expenses included \$3,356,837 in administrative expenses and \$52,520,761 in benefits paid to participants and beneficiaries.

## **SUMMARY ANNUAL REPORT ANNUITY FUND OF OPERATING ENGINEERS LOCAL 513**

This is a summary of the annual report for the ANNUITY FUND OF OPERATING ENGINEERS LOCAL 513, Employer Identification No. 43-1712261, Plan No. 001, for the period May 1, 2022 to April 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **BASIC FINANCIAL STATEMENT**

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$15,938.700. These expenses included \$843,783 in administrative expenses and \$15,094,917 in benefits paid to participants and beneficiaries. A total of 9,153 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$275,663,237 as of April 30, 2023, compared to \$263,244,960 as of May 1, 2022. During the plan year the plan experienced an increase in its net assets of \$12,418,277. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$28,356,977, including employer contributions of \$21,882,739, gains of \$2,177,411 from the sale of assets, earnings from investments of \$-80,769 and other income of \$4,377,596.

### **MINIMUM FUNDING STANDARDS**

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

This is a summary of the annual report for the VACATION FUND OF OPERATING ENGINEERS LOCAL 513, Employer Identification No. 43-6196259, Plan No. 501, for the period May 1, 2022, to April 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **BASIC FINANCIAL STATEMENT**

The value of plan assets, after subtracting liabilities of the plan, was \$33,370 as of April 30, 2023, compared to \$-56,686 as of May 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$90,056. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$13,244,577. This income included employee contributions of \$13,024,039 and earnings from investments of \$17,852. Plan expenses were \$13,154,521. These expenses included \$100,842 in administrative expenses and \$13,053,679 in benefits paid to participants and beneficiaries.

### **Premium Assistance Under Medicaid and the Children's Health Insurance Program (CHIP)**

If you or your children are eligible for Medicaid or CHIP and you're eligible for health coverage from your employer, your state may have a premium assistance program that can help pay for coverage, using funds from their Medicaid or CHIP programs. If you or your children aren't eligible for Medicaid or CHIP, you won't be eligible for these premium assistance programs but you may be able to buy individual insurance coverage through the Health Insurance Marketplace. If you or your dependents are already enrolled in Medicaid or CHIP and you live in a State listed below, contact your State Medicaid or CHIP office to find out if premium assistance is available.

#### **Paperwork Reduction Act Statement**

According to the Paperwork Reduction Act of 1995 (Pub. Also, notwithstanding any other provisions of law, no person shall be subject to penalty for failing to comply with a collection of information if the collection of information does not display a currently valid OMB control number. See 44 U.S.C. 3512.
