This is a summary of the annual report for the HEALTH & WELFARE TRUST FUND OF THE IUOE LOCALS NO. 877 AND 70, (Employer Identification No. 04-2624972, Plan No. 501) for the period January 1, 2021 to December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$23,606,892 as of December 31, 2021 compared to \$19,810,985 as of January 1, 2021.

This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$23,829,092. This income included employer contributions of \$17,213,220, employee contributions of \$3,090,544, realized losses of \$10,687 from the sale of assets, earnings from investments of \$3,465,548 and PPP loan forgiveness of \$70,467.
