Under the Plan, you can change your election as of March 1st or October 1st of each year to increase or decrease the amount deferred. You can terminate your election at any time.

<p>The Plan allows you to have your Employer withhold, on a pre-tax basis, salary or wage deferrals ranging from \$1 to \$9 per hour. For 2024 you can defer up to the maximum amount of \$23,000, which is adjusted annually by the Internal Revenue Service. The Plan also allows you to change your election as of March 1st or October 1st of each year or stop your election at any time. Please select the pre-tax hourly or wage deferral you wish to have withheld each pay period by your Employer.</p>	<p>If you are age 50 or older in 2024, you may elect an additional \$1 to \$3 per hour as a "catch-up" contribution.</p> <p>The maximum contribution for 2024 is \$30,500.</p>
