NOTICE OF WITHHOLDING ON MONTHLY PENSION PAYMENTS

Under federal law, your monthly pension payments will be subject to federal income tax withholding, like wages, unless you decide not to have taxes withheld.

You may choose not to have withholding apply to your pension payments. All you have to do is check **Option A** on the election form, which appears on the reverse side, sign and date it and return it to the Fund Office.

If you do not return the election form, federal income tax will be withheld from your benefit checks at the rate specified in the tax law, which is calculated as if you were a married individual claiming three withholding allowances or exemptions. On this basis, no tax will be withheld if your monthly benefit is less than \$1,160.00

The enclosed election form can also be used to revoke an election not to have federal income tax withheld. If you choose **Option A** and then change your mind, all you have to do is ask for another election form, check the option you want, sign and date the form, and return it to the Fund Office. You may make or revoke elections as often as you wish. Additional election forms may be obtained from the Pension Fund Office at P.O. Box 99219, Troy, MI 48099-9219 or from the website www.iw25fringe.org.

Even if you elect not to have federal income tax withheld, you are liable for payment of federal income tax on your pension. You may be subject to tax penalties under the estimated tax payment rules if your payments of estimated tax and withholding, if any, are not adequate.
