## SUMMARY ANNUAL REPORT

### FOR IBEW 125 – PGE HEALTH AND WELFARE TRUST

This is a summary of the annual report of the IBEW 125 – PGE Health and Welfare Trust, E.I.N. 93-1204757, Plan No. 508, for the year ended December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### Insurance Information

The plan has a contract with Nationwide Life Insurance Company to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended December 31, 2024 was \$100,543.

#### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$15,818,130 as of December 31, 2024, compared to \$13,241,620 as of January 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$2,576,510. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$17,386,657 including employer contributions of \$13,661,019, participant contributions of \$2,057,739 and gains from investments of \$1,667,899.

Plan expenses were \$14,810,147. These expenses included \$961,597 in administrative expenses and \$13,848,550 in benefits paid to participants and beneficiaries.

1. An independent auditor's report;
2. financial information and information on payments to service providers;
3. assets held for investment;
4. transactions in excess of 5% of the plan assets; and
5. insurance information, including sales commissions paid by insurance carriers.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
