Summary Annual Report for the IN/KY/OH RGNL COUNCIL OF CARPENTERS WELFARE FUND (Revised January 2019)

This is the summary annual report for the IN/KY /OH RGNL COUNCIL OF CARPENTERS WELFARE FUND, EIN 35-6042362, Plan number 501 for the period January 1, 2017 to December 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$44,708,065 as of December 31, 2017, compared to \$27,656,238 as of January 1, 2017. During the plan year the plan experienced an increase in its net assets of \$17,051,827. This increase includes unrealized appreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$174,947,887 including employer contributions of \$146,277,825, employee contributions of \$19,050,335, realized gains of \$130,365 from the sale of assets, and earnings from investments of \$9,304,081.

Plan expenses were \$157,896,060. These expenses included \$9,498,487 in administrative expenses, \$148,397,573 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
