SUMMARY ANNUAL REPORT FURNITURE AND INDUSTRIAL CARPENTERS HEALTH PLAN

This is a summary of the annual report of the Furniture and Industrial Carpenters Health Plan, EIN 94-2621654, for the year ended May 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., Delta Dental of California, Safeguard Health Plans, Inc., Vision Service Plan, and Prudential Insurance Company of America to pay certain medical, dental, vision, life, and accidental death and dismemberment benefits incurred under the terms of the plan. The total premiums paid for the plan year ending May 31, 2022 is \$2,456,134.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$2,483,651 as of May 31, 2022, compared to \$2,281,315 as of June 1, 2021. During the plan year the plan experienced an increase in its net assets of \$202,336. During the plan year, the plan had total income of \$2,703,295, including employer contributions of \$2,673,501, participant contributions of \$5,679, earnings from investments of \$688 and other income of \$23,427.

Plan expenses were \$2,500,959. These expenses included \$151,156 in administrative expenses and \$2,349,803 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 7180 Koll Center Parkway, Suite 200, Pleasanton, CA 94566, and at the U.S. Department of Labor in Washington, DC or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
