SUMMARY ANNUAL REPORT FURNITURE AND INDUSTRIAL CARPENTERS HEALTH PLAN

This is a summary of the annual report of the Furniture and Industrial Carpenters Health Plan, EIN 94-2621654, for the year ended May 31, 2018. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., Delta Dental of California, Safeguard Health Plans, Inc., Vision Service Plan, and The Prudential Insurance Company of America to pay certain medical, dental, vision, life, and accidental death and dismemberment benefits incurred under the terms of the plan. The total premiums paid for the plan year ending May 31, 2018 were \$2,850,382.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,675,508 as of May 31, 2018, compared to \$1,323,597 as of June 1, 2017. During the plan year the plan experienced an increase in its net assets of \$351,911. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$3,415,319, including employer contributions of \$3,401,694, employee contributions of \$10,368, and earnings from investments of \$3,257.

Plan expenses were \$3,063,408. These expenses included \$151,644 in administrative expenses, and \$2,911,764 in benefits paid to participants.
