## SUMMARY ANNUAL REPORT FURNITURE AND INDUSTRIAL CARPENTERS HEALTH PLAN

This is a summary of the annual report of the Furniture and Industrial Carpenters Health Plan, EIN 94-2621654, for the period June 1, 2022 through May 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### Insurance Information

The plan has contracts with Delta Dental of California, Kaiser Foundation Health Plan Inc, The Prudential Insurance Company of America, Safeguard Health Plans, Inc., a California Corporation and Vision Service Plan to pay health, dental, vision, life insurance, HMO and accidental death and dismemberment benefit claims incurred under the terms of the plan. The total premiums paid for the plan year ending May 31, 2023 were \$2,370,860.

### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$2,652,679 as of May 31, 2023, compared to \$2,483,651 as of June 1, 2022. During the plan year the plan experienced an increase in its net assets of \$169,028. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$2,890,458, including employer contributions of \$2,865,823, employee contributions of \$1,448, earnings from investments of \$18,903, and other income of \$4,284.

Plan expenses were \$2,721,430. These expenses included \$165,461 in administrative expenses, and \$2,555,969 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 7180 Koll Center Parkway, Suite 200, Pleasanton, CA 94566, and at the U.S. Department of Labor in Washington, DC or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
