SUMMARY ANNUAL REPORT FURNITURE AND INDUSTRIAL CARPENTERS HEALTH PLAN

This is a summary of the annual report of the Furniture and Industrial Carpenters Health Plan, EIN 94-2621654, for the year ended May 31, 2016. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., Delta Dental of California, Safeguard Health Plans, Inc., A California Corporation, Vision Service Plan, and The Prudential Insurance Company of America to pay certain medical, dental, vision, life, and accidental death and dismemberment benefits incurred under the terms of the plan. The plan has terminated the contract with United Healthcare of California during the plan year. The total premiums paid for the plan year ending May 31, 2016 totaled \$2,448,543.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,046,139 as of May 31, 2016, compared to \$824,627 as of June 1, 2015. During the plan year the plan experienced an increase in its net assets of \$221,512. During the plan year, the plan had total income of \$2,827,062, including employer contributions of \$2,797,930, participant contributions of \$27,121, earnings from investments of \$296, and other income of \$1,715.

Plan expenses were \$2,605,550. These expenses included \$139,702 in administrative expenses and \$2,465,848 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
