

## ***SUMMARY ANNUAL REPORT***

### **INSULATORS LOCAL 84 HEALTH CARE PLAN**

This is a summary of the annual report for the Insulators Local 84 Health Care Plan, (EIN #30-0224279 PN 501) for the year ended May 31, 2017. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **INSURANCE INFORMATION**

The plan has a contract with an insurance carrier to pay excess medical claims incurred under the plan. Total premiums paid during the plan year were \$106,546.

#### **BASIC FINANCIAL STATEMENT**

Benefits under the plan are provided by a Trust Fund. Plan expenses were \$2,543,374, which included \$190,878 in administrative expenses and \$2,352,496 in benefits paid to participants and beneficiaries. A total of 143 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$(542,457) as of May 31, 2017, compared to \$473,503 as of May 31, 2016. During the plan year, the plan experienced a decrease in its net assets of \$(1,015,960). This decrease includes unrealized appreciation/ (depreciation) in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,527,414 including employer contributions of \$1,155,046, participant contributions of \$275,417, unrealized and realized losses of \$(19,455), income from investments of \$23,452, and other income of \$92,954.

#### **YOUR RIGHTS TO ADDITIONAL INFORMATION**

You have the right to receive a copy of the full annual report, or any part thereof, upon request. Included in that report is an accountant's report, schedule of assets held for investment purposes, schedule of reportable transactions and actuarial information regarding the funding of the plan.

The charge to cover copying costs given above does not include a charge for copying these portions of the report, which are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan, 33 Fitch Blvd., Youngstown, Ohio, 44515, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor on payment of copying costs.
