SUMMARY ANNUAL REPORT IRON WORKERS ST. LOUIS DISTRICT COUNCIL ANNUITY TRUST FUND

This is a summary of the annual report for the IRON WORKERS ST. LOUIS DISTRICT COUNCIL ANNUITY TRUST FUND, (Employer Identification No. 43-1267550, Plan No. 004) for the period November 1, 2017 to October 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$19,438,530. These expenses included \$1,133,290 in administrative expenses and \$18,305,240 in benefits paid to participants and beneficiaries. A total of 6,096 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$232,743,005 as of October 31, 2018 compared to \$228,582,694 as of November 1, 2017. During the plan year the plan experienced an increase in its net assets of \$4,160,311. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$23,598,841, including employer contributions of \$19,540,803, gains of \$494,493 from the sale of assets, earnings from investments of \$3,463,390 and other income of \$100,155.

The plan has a contract with Massachusetts Mutual Life which allocates funds toward individual policies.

YOUR RIGHTS TO ADDITIONAL INFORMATION

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An accountant's report;
2. Assets held for investment;
3. Transactions in excess of 5 percent of the plan assets;
4. Insurance information including sales commissions paid by insurance carriers; and
5. Information regarding any common or collective trust, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

To obtain a copy of the full annual report, or any part thereof, write or call the office of the Plan Administrator. The charge to cover copy costs will be no more than \$0.25 per page for any part thereof.

These portions of the report are furnished without charge.
