### Hearing Aid Benefit Improvement Effective June 1, 2017

**To:** Active and Retired Members Participating in the Iron Workers St. Louis District Council Welfare Trust Fund (Other than Participants Enrolled in the Medicare Advantage Prescription Drug Plan (MAPD) Offered by UnitedHealthcare)

The Board of Trustees of the Iron Workers St. Louis District Council Welfare Trust Fund (the Fund) is pleased to announce improvements to the hearing aid benefits offered by the Fund. Please read this Summary of Material Modification (SMM) carefully and share it with your family. You should keep it with your Summary Plan Description (“SPD”) and other SMMs. The changes explained in this notice are effective June 1, 2017.

#### Hearing Aid Benefit Improvements

Effective June 1, 2017, you will have access to enhanced hearing aid coverage through the Fund. The hearing aid benefit is administered by the EPIC Hearing Service Plan (EPIC). The improved benefit reduces your deductible from \$500 to \$250 when you see an EPIC provider. If you see an out-of-network provider, your deductible will remain the same at \$500 for the benefit year. The hearing benefit will now be available once every two years—instead of once every four years. The annual limit is not changing.
