SUMMARY ANNUAL REPORT

MAHONING AND TRUMBULL COUNTY BUILDING TRADES INSURANCE FUND

This is a summary of the annual report for the Mahoning and Trumbull County Building Trades Insurance Fund, (EIN #34-0746419 PN 501) for the year ended September 30, 2025. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The plan has a contract with an insurance carrier to pay excess medical claims incurred under the plan up to the maximum amount allowed by the policy. Total premiums paid during the plan year were \$901,338.

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a Trust Fund. Plan expenses were \$15,427,836, which included \$530,730 in administrative expenses and \$14,897,106 in benefits paid to participants and beneficiaries. A total of 1,084 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$33,607,555 as of September 30, 2025, compared to \$31,045,021 as of September 30, 2024. During the plan year, the plan experienced an increase (decrease) in its net assets of \$2,562,534. This increase (decrease) includes unrealized appreciation / (depreciation) in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost assets acquired during the year. The plan had total income (loss) of \$17,990,370 including employer contributions of \$15,073,327, participant contributions of \$543,308, income from investments of \$1,192,267, gains (losses) on investments of \$1,164,170, and other income of \$17,298.

The charge to cover copying costs given above does not include a charge for copying these portions of the report, which are furnished without charge.
