This Notice, called a "Summary of Material Modification" (SMM), advises you of a change in the information presented in the Plan's Summary Plan Description (SPD) that was previously provided to you. Please read this SMM and keep it with your 2014 Summary Plan Description and if you have any questions, contact the Fund Office at (800) 638-8824.

**Effective immediately**, the Board of Trustees hereby amends the Summary Plan Description ("SPD") as follows:

**I. Plan Coverage of Immunization Expenses**

**A. CVS Pharmacy Vaccination Network**

The Board of Trustees is pleased to announce the partnership with CVS Caremark which offers a comprehensive immunization program that provides plan members convenient access to no-cost vaccinations at their local pharmacy. The CVS Pharmacy Vaccination Network program offers coverage of all Affordable Care Act ("ACA") preventive immunizations at more than 9,900 CVS Pharmacy locations nationwide. Claims will be submitted through the Plan's prescription benefit like any other drug claim and will include the cost of the immunization as well as the cost for administering the immunization in the pharmacy.

The Summary Plan Description ("SPD") will be amended as follows:

**SECTION: PRESCRIPTION DRUG BENEFITS**

**1. The following new section entitled "Immunization Benefits" is added on the page labeled "Prescription Drug Benefits" of the SPD:**

The Plan provides vaccination coverage for certain ACA-preventive immunizations for you and your eligible dependents. ACA-preventive immunizations may be obtained with no cost to you through a doctor's visit, as explained in the "Detailed Explanation of Benefits" section, or by visiting a participating CVS pharmacy.

CVS or one of its affiliated pharmacies are the only pharmacies participating in this program. Be sure to locate a participating pharmacy. For assistance in locating a participating pharmacy, please call CVS/Caremark at (866) 262-8503 or go to [www.caremark.com](http://www.caremark.com) on the internet. The immunization coverage available at CVS or its affiliated pharmacies includes all ACA-preventive immunizations listed below, including the flu vaccine.
