## VII. Legal Report

### A. 2023 Benefits

Mr. Judd updated the Committee that the renewal agreements with BCBS, BCN, HAP, Humana, and Priority Health have been provided by Manquen Vance for review. BCBS, BCN, and HAP included a right to re-rate if the VEBA's covered population changes by more than 10%. VMT has requested that the language be removed from the applicable agreements. The Human and Priority renewals did not include a right to re-rate and are acceptable for signature. However, Humana has also requested that the Board sign an acknowledgement that Humana's share of open enrollment costs/expenses be capped at \$5,000.

Mr. Judd also updated the Committee that the renewal agreements for dental and vision benefits have not been provided at this point. He recommended that the Board direct BeneSys to reach out to the VEBA's dental and vision insurance providers regarding the 2023 renewal agreements. Ms. Crosby will do so.

Mr. Judd informed the Committee that all seven (7) Board members' term of office are scheduled to expire as of 12/31/2022. Pursuant to Section 8.4 of the Trust Agreement, vacancies due to expiration of term of office are to be filled as follows:

- (a) In the event of a vacancy of the seat previously filled by the appointee of the Mayor of Detroit, the replacement Board member shall be appointed by the Mayor; and
- (b) In the event of a vacancy of a seat previously filled by an appointee of the Detroit Retired City Employees Association, the replacement Board member shall be appointed by the Detroit Retired City Employees Association.

Chairman Sheehan asked the letters to be drafted for all Trustees to continue their appointments.

## **C. Summary Annual Report as of 12/31/2022**

Mr. Judd updated the Committee that they are awaiting final valuation report from GRS as of 12/31/2021 so that census data and actuarial liabilities/funding status can be updated. Ms. Crosby will follow up with GRS again regarding the final valuation for 12/31/2021.
