### **C. Financial Statement – January 2023**

**Motion** was made by Trustee Lightsey and seconded by Trustee Stevens to approve and accept the Financial Statements for January 2023. **Motion** passed unanimously.

### **E. Bills for Approval**

## **VI. Administrative Reports**

### **A. BeneSys Barometers through January 2023**

The BeneSys Barometers were provided as follows:

**Eligible by Month** - A report showing number of eligible members by month through the month of January 2023. This report reflects the breakdown of eligible members by HRA, HAP, Blue Care Network, and Blue Cross Blue Shield Medicare Advantage, Humana and Priority Health and a total of all participants. The number of total eligible participants, as of January 2023, was 5,965, which is a decrease of 17 eligible participants from December 2022.

**Income and Expenses by Month** - A report showing the income and expenses, excluding investment income, for the months of January 2021 thru January 2023, was provided. This report shows an expense of \$790,212 at the end January 2023.

**Investment Income by Month** - A report showing the investment gain/loss for the months of January 2021 thru January 2023 was provided.

**Fund Assets** - A report showing the assets and equity of the Fund for the months of January 2021 through January 2023 was provided for review. This report shows both Assets and Fund Equity have increased slightly.

**Benefit and Operating Costs by Month** – A report showing the total benefit and operating costs for the months of January 2021 through January 2023 was provided.

**Benefit Premiums Paid** – A report showing the total premiums paid for medical, dental and vision for the months of January 2021 through January 31, 2023, was reviewed.

**Motion** was made by Trustee Wise-Johnson and seconded by Trustee Stevens to approve the BeneSys Barometers for January 2023 as presented. **Motion** passed unanimously.

## **VII. Financial Consultants**

### **A. Monthly Performance Report – February 28, 2023**

Mr. Leonard gave the Board an update regarding the performance of the portfolio. For the first quarter 2023 the portfolio is up 2%. Discussion took place regarding the recently failed banks and the security of the Trust funds.

**Motion** was made by Trustee Stevens and seconded by Trustee Gayney to approve the Plante Moran contract and have Chairman Sheehan sign it. **Motion** passed unanimously.

BeneSys provided the Board with the response from GRS as to when the December 31, 2022 actuarial valuation work will begin and that they should have it completed June 2023.

### **B. OE Book Benefit Summary Description**

At the end of Open Enrollment last year, the Board wanted to review the Benefit Summary Descriptions provided in the books. They feel the information should be more formatted, consistent between vendors and easier to read and understand.

### **C. Open Enrollment Options**

The Board wanted to begin discussing the Open Enrollment process and materials. They are interested in potentially consolidating and updating the format of the information.

### **D. BCBS MA Group Utilization Reporting**

BeneSys provided communication from BCBS MA stating that they are producing group utilization reporting and would like to present some of this information to the Board. The Board agreed to have them present at the April 25, 2023, Board Meeting.
