This is the summary annual report for the NORTHWESTERN OHIO PLUMBERS AND PIPEFITTERS ACTIVE HEALTH AND WELFARE PLAN AND TRUST, EIN 34-4443218, Plan number 501 for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has a contract with an insurance carrier to pay claims incurred under the terms of the plan. Total premiums paid during the plan year were \$477,285.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$35,439,387 as of December 31, 2022, compared to \$35,620,966 as of January 1, 2022. During the plan year the plan experienced an increase or (decrease) in its net assets of \$-187,579. This increase or (decrease) includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$19,883,107 including employer contributions of \$22,930,179, employee contributions of \$146,034, realized gains or (losses) of \$2,120 from the sale of assets, and earnings from investments of \$-3,263,641 and other income of \$68,415.

Plan expenses were \$20,064,686. These expenses included \$1,208,908 in administrative expenses, \$18,855,778 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
