SUMMARY ANNUAL REPORT for OHIO CARPENTERS' HEALTH PLAN

This is a summary of the annual report for the Ohio Carpenters' Health Plan, 45-0593187/501, for 05/01/2020 through 04/30/2021. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

This is a self-insured plan under ERISA.

The plan has contracts with The Union Labor Life Insurance Company to pay certain claims incurred under the terms of the plan. The total premiums paid for the plan year ending 04/30/2021 were \$1,757,730.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$69,921,007 as of 04/30/2021, compared to \$52,392,759 as of 05/01/2020. During the plan year the plan experienced an increase in its net assets of \$17,528,248. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$145,847,099, including employer contributions of \$110,929,509, employee contributions of \$21,270,886, gains of \$712,830 from the sale of assets, earnings from investments of \$9,394,874, and other income of \$3,539,000. Plan expenses were \$128,318,851. These expenses included \$9,964,631 in administrative expenses and \$118,354,220 in benefits paid to participants and beneficiaries.

3. Assets held for investment;
4. Transactions in excess of 5% of plan assets; and

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes, if any, will be included as part of that report. The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 700 Tower Drive, Suite 300, Troy, MI 48098-2808 and at the U.S. Department of Labor in Washington, DC, or obtain a copy from the U.S. Department of Labor upon payment of copying costs.
