### SUMMARY ANNUAL REPORT FOR OHIO CARPENTERS' ANNUITY PLAN

This is a summary of the Form 5500 annual report for the Ohio Carpenters' Annuity Plan (the "Plan"), EIN 34-1778747, for the year ended April 30, 2024. The Form 5500 annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 ("ERISA"). Your plan is a multiemployer defined contribution plan.

#### Basic Financial Statement

Benefits under the plan are provided by the Trust.

Plan expenses were \$26,628,438. These expenses included \$2,034,446 in administrative expenses and \$24,593,992 in benefits paid to participants and beneficiaries. A total of 16,204 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$409,411,534 as of April 30, 2024, compared to \$370,350,488 as of May 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$39,061,046. This increase included unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$65,689,484 including employer contributions of \$35,512,872, net earnings from investments of \$29,595,015 and other income of \$581,597.

#### Your Rights to Additional Information

You have the right to receive a copy of the full annual report, or any part thereof, upon request. The items listed below are included in that report:

1. an accountant's report;
2. financial information and information on payments to service providers;
3. assets held for investment;
4. loans or other obligations in default or classified as uncollectible; and
5. information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

The charge to cover copying costs will be \$10.75 for the full annual report or \$.25 per page for any part thereof.

You also have the right to receive from the Fund Administrator, on request and at no charge, a statement of the assets and liabilities of the Plan and accompanying notes or a statement of income and expenses of the Plan and accompanying notes, or both. If you request a copy of the full annual report from the Fund Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 700 Tower Drive, Suite 300, Troy, Michigan and the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
