

**SUMMARY ANNUAL REPORT**  
**for**  
**PLUMBING AND PIPE FITTING INDUSTRY LOCAL 219 ANNUITY FUND**  
*March 2021*

This is a summary of the annual report for the Plumbing and Pipe Fitting Industry Local 219 Annuity Fund, 51-0154940/001, for 05/01/2019 through 04/30/2020. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

*Basic Financial Statement*

Benefits under the plan are provided by a trust. Plan expenses were \$1,485,598. These expenses included \$106,369 in administrative expenses and \$1,379,229 in benefits paid to participants and beneficiaries. A total of 518 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$25,969,866 as of 04/30/2020, compared to \$25,263,867 as of 05/01/2019. During the plan year the plan experienced an increase in its net assets of \$705,999. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$2,191,597, including employer contributions of \$1,687,509, employee contributions of \$200,024, earnings from investments of \$192,752, and other income of \$111,312.

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
