SUMMARY ANNUAL REPORT

PLUMBERS AND PIPEFITTERS LOCAL UNION NO. 396 SECURITY PLAN

This is a summary of the annual report for the Plumbers and Pipefitters Local Union No. 396 Security Plan, (EIN: #34-6638626 PN: 001) for the year ended March 31, 2025. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a Trust Fund. Plan expenses were \$3,601,901 which included \$286,275 in administrative expenses and \$3,315,626 in benefits paid to participants and beneficiaries. A total of 648 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$30,856,636 as of March 31, 2025, compared to \$29,989,777 as of March 31, 2024. During the plan year, the plan experienced an increase (decrease) in its net assets of \$866,859. This increase (decrease) includes unrealized appreciation/ (depreciation) in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income (loss) of \$4,468,760 including employer contributions of \$2,780,298, income from investments of \$225,400, other income of \$128,339, and gains (losses) on investments of \$1,334,723.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of the report. The charge to cover copying costs given above does not include a charge for copying these portions of the report, which are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan, 3660 Stutz Drive, Suite 101, Canfield, Ohio 44406, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor on payment of copying costs.
