THIS IS A SUMMARY OF THE ANNUAL REPORT FOR THE PLUMBERS & PIPEFITTERS MEDICAL FUND, (EMPLOYER IDENTIFICATION NO. 53-0190932, PLAN NO. 501) FOR THE PERIOD JANUARY 1, 2024 TO DECEMBER 31, 2024. THE ANNUAL REPORT HAS BEEN FILED WITH THE EMPLOYEE BENEFITS SECURITY ADMINISTRATION, AS REQUIRED UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA).

THE VALUE OF PLAN ASSETS, AFTER SUBTRACTING LIABILITIES OF THE PLAN, WAS \$53,429,974 AS OF DECEMBER 31, 2024 COMPARE TO \$50,577,983 AS OF JANUARY 1, 2024. DURING THE PLAN YEAR THE PLAN EXPERIENCED AN INCREASE IN ITS ASSETS OF \$2,851,991. THIS INCREASE INCLUDES UNREALIZED APPRECIATION OR DEPRECIATION IN THE VALUE OF PLAN ASSETS; THAT IS, THE DIFFERENCE BETWEEN THE VALUE OF THE PLAN'S ASSETS AT THE END OF THE YEAR AND THE VALUE OF THE ASSETS AT THE BEGINNING OF THE YEAR, OR THE COST OF ASSETS ACQUIRED DURING THE YEAR. DURING THE PLAN YEAR, THE PLAN HAD TOTAL INCOME OF \$28,711,649. THIS INCOME INCLUDED EMPLOYER CONTRIBUTIONS OF \$21,337,814, EMPLOYEE CONTRIBUTIONS OF \$1,003,376, REALIZED GAINS OF \$2,587,262 FROM THE SALE OF ASSETS AND EARNINGS FROM INVESTMENTS OF \$1,428,870. PLAN EXPENSES WERE \$25,859,658. THESE EXPENSES INCLUDED \$1,459,912 IN ADMINISTRATIVE EXPENSES AND \$24,399,746 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES.
