

Summary Annual Report

This is a summary of the annual report for the ROOFERS UNION LOCAL 30 COMBINED ANNUITY FUND, (Employer Identification No. 23-2567112, Plan No. 001) for the period January 1, 2016 to December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$5,711,870. These expenses included \$342,614 in administrative expenses and \$5,369,256 in benefits paid to participants and beneficiaries. A total of 2,574 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$78,053,297 as of December 31, 2016 compared to \$75,422,958 as of January 1, 2016. During the plan year the plan experienced an increase in its net assets of \$2,630,339. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$8,342,209, including employer contributions of \$4,580,527, gains of \$297,147 from the sale of assets, earnings from investments of \$3,450,239 and other income of \$14,296.
