RE: **Annual Flu Shot Reminder—Different Procedure—Visit your Local Pharmacy**

Dear Member:

We are pleased to be able to inform you of a new process regarding the Annual Flu Shots.

In the past years, you and your eligible spouse and/or eligible dependents were provided with a one-day schedule and list of employers and times to make yourself available for a Flu Shot.

This year, you and your eligible spouse and/or eligible dependents will instead be able to visit a Pharmacy for your flu shot at no charge (\$0 dollars) to you, your eligible spouse and/or eligible dependents. You will need to bring a photo ID and your Prescription ID Card along with you when you go to get your flu shot.

Attached is a list of the pharmacies that are available to obtain your flu shot. You may also call also call the number on your Rx card, or 800-424-0472 (Magellan Rx Management telephone number) if you need assistance in locating a pharmacy or go onto www.magellanrx.com and register for the member portal and search for a pharmacy. We recommend that you call the pharmacy ahead of going to the pharmacy to ensure that they have the flu vaccine available that day. If you have any issues at the pharmacy regarding the no cost (\$0 fee), please ask the pharmacist to contact our office for confirmation.

What should I do during flu season?

Visit your local Magellan Rx participating pharmacy if you and your dependents decide to get your annual flu shot. Again, the Trust is providing this immunization at no cost to you or your covered dependents. According to medical experts, getting vaccinated is the first and most important step in protecting against this serious disease (flu also known as influenza). Vaccination efforts should continue as long as influenza viruses are circulating. (If you have any questions or concerns, consult with your physician.)

Who should get vaccinated?

Medical and governmental officials have stated that persons who are at least 6 months of age should get a flu vaccine this season. (If your physician has informed you not to get a flu shot for some personal reason, that is a different issue.) It's especially important for some people who fit in certain categories to get vaccinated as soon as possible, including the following:

- ❖ People who are at high risk of developing serious complications like pneumonia if they get sick with the flu, this includes:
 - People who have certain medical conditions, including asthma, diabetes, and chronic lung disease
 - People who live with or care for others who are high risk of developing the above mentioned medical conditions.
 - Pregnant Women
 - People 65 years and older
