

SUMMARY ANNUAL REPORT

FOR SIGN, PICTORIAL, AND DISPLAY INDUSTRY WELFARE FUND

This is a summary of the annual report of the Sign, Pictorial, and Display Industry Welfare Fund, E.I.N. 94-6087594, Plan No. 501, for the year ended December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., United of Omaha Life Insurance Company, HCC Life Insurance Company, Vision Service Plan, and Claremont Behavioral Services, to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended December 31, 2024 was \$ 4,760,858.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ended December 31, 2024, the premiums paid under such "experience-rated" contracts were \$69,343 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$42,869.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$15,099,882 as of December 31, 2024, compared to \$14,271,239 as of January 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$828,643. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$8,465,023, including employer contributions of \$7,002,333, participant contributions of \$403,202, other contributions of \$27,765, and gains from investments of \$1,031,723.

Plan expenses were \$7,636,380. These expenses included \$759,365 in administrative expenses and \$6,877,015 in benefits paid to or for participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
