SUMMARY ANNUAL REPORT

FOR BRICKLAYERS AND ALLIED CRAFTSMEN LOCAL UNION NO. 11 OF CALIFORNIA PENSION TRUST FUND

This is a summary of the annual report for the Bricklayers and Allied Craftsmen Local Union No. 11 of California Pension Trust Fund, E.I.N. 95-3519963, Plan No. 002, for the year ended May 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$1,058,300. These expenses included \$180,199 in administrative expenses and \$878,101 in benefits paid to or for participants and beneficiaries. A total of 1,112 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$12,435,433 as of May 31, 2024, compared to \$11,871,144 as of June 1, 2023. During the plan year the plan experienced a increase in its net assets of \$564,289. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had income of \$1,622,589, including employer contributions of \$204,703 and a gain from investments of \$1,417,886.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An independent auditor's report;
2. financial information and information on payments to service providers;
3. fiduciary information, including non-exempt transactions between the plan and parties-in-interest (that is, persons who have certain relationships with the plan);
4. information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates;
5. assets held for investment; and
6. transactions in excess of 5% of the plan assets.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (1050 Lakes Drive, Suite 120, West Covina, California 91790) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
