## **SUMMARY ANNUAL REPORT FOR THE SOUTHERN NEVADA TEAMSTERS LOCAL 631 VACATION PLAN**

This is a summary of the annual report for the Southern Nevada Teamsters Local 631 Vacation Plan (the “Plan”), Employer Identification Number 88-0411470, Plan No. 502, for the period May 1, 2023 to April 30, 2024 (the “Plan Year”). The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

The value of Plan assets, after subtracting liabilities of the Plan, was \$297,413 as of April 30, 2024, compared to \$492,873 as of May 1, 2023. During the year, the Plan experienced a decrease in its net assets of \$195,460. During the Plan Year, the Plan had total income of \$6,212,140, including employer contributions of \$6,205,830 and earnings from investments of \$6,310. Plan expenses were \$6,407,600. These expenses included \$50,097 in administrative expenses and \$6,357,503 in benefits paid to participants and beneficiaries.
