## SUMMARY ANNUAL REPORT FOR THE TEAMSTERS LOCAL 631 CONVENTION INDUSTRY VACATION SAVINGS PLAN

This is a summary of the annual report for the Teamsters Local 631 Convention Industry Vacation Savings Plan (the “Plan”), Employer Identification Number 82-6577059, Plan No. 503, for the period May 1, 2023 to April 30, 2024 (the “Plan Year”). The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### BASIC FINANCIAL STATEMENT

The value of Plan assets, after subtracting liabilities of the Plan, was \$48,417 as of April 30, 2024, compared to \$22,336 as of May 1, 2023. During the year, the Plan experienced an increase in its net assets of \$26,081. During the Plan Year, the Plan had total income of \$8,007,330, which is comprised entirely of employer contributions. Plan expenses were \$7,981,249. These expenses included \$62,067 in administrative expenses and \$7,919,182 in benefits paid to participants and beneficiaries.
