## IMPORTANT CHANGES TO YOUR HEALTH AND WELFARE BENEFITS EFFECTIVE JANUARY 1, 2017

Dear Retiree:

The Committee that is responsible for the management of the UAW Retirees of the Dana Corporation Health and Welfare Trust ("Trust") annually reviews the benefits that the Trust offers to eligible participants. The Committee takes into consideration factors which influence the Trust's ability to provide benefits such as health care cost and expected inflation, utilization, and actual and expected investment returns. They also review the quality of benefit delivery and retiree satisfaction.

***The Committee will make the following benefit changes for 2017:***

## **Prescription Drug Plan Changes**

Due to the significant cost of providing prescription drug coverage, the Committee has also determined that changes are required to the pharmacy program.

### **Prescription Drug Tier Changes:**

The following changes will be made to the tier structure and copayments charged by tier:

<b>Drug Classification</b>	<b>Current Tier</b>	<b>2017 Tier</b>
Generic	Generic	Generic
Brand – No Generic Equivalent	Single Source Brand	Preferred Brand or Non-Preferred Brand
Brand – Generic Equivalent	Multi-Source Brand	Preferred Brand or Non-Preferred Brand

Preferred Brands are selected drugs that are more clinically effective and/or cost-effective than similar medications that can be used to treat a medical condition. A portion of the savings is passed on to you by a lower copayment. Non-Preferred Brands are drugs that usually have a Preferred Brand alternative medication that is equally effective and less costly.

If you have any questions as to whether the brand name drugs you are taking are Preferred or Non-Preferred, The Standard Drug list (which identifies drugs by the Tiers shown above) is available:

- By asking your physician or pharmacist

CVS Caremark will also be contacting you prior to January 1, 2017 if you are currently taking a prescription drug that will be considered a Non-Preferred Brand or excluded from the Preferred Drug list.

## **Prescription Drug Copayment Changes:**

<b>Drug Tier</b>	<b>30 Day Retail</b>	<b>90 Day Mail Order</b>
Generic	\$10	\$20
Preferred Formulary Brand	\$35	\$70
Non-Preferred Formulary Brand	\$85	\$170

### **Generic Drugs - \$10 Retail/\$20 Mail Order**

If you are currently taking a generic medication your copayment will be \$10 for a 30-day retail supply and \$20 for a 90-day mail order supply.

### **Preferred Formulary Brand Drugs - \$35 Retail/\$70 Mail Order**

If you are taking a brand name medication that is a Preferred Brand, your copayment will be \$35 for a 30-day retail supply and \$70 for a 90-day mail order supply.

### **Non-Preferred Brand Drugs - \$85 Retail/\$170 Mail Order**

If you are taking a brand medication that is a Non-Preferred Brand, your copayment will be \$85 for a 30-day retail supply and \$170 for a 90-day mail order supply.

You will not receive new identification cards from CVS/Caremark. Continue to use your current CVS/Caremark cards in 2017.

## **Other Changes to Help Manage Your Prescription Drugs**

Along with the changes discussed above, an Advanced Control Specialty Formulary Pharmacy program will be implemented to assist those members using specialty drugs. Additionally, the vaccination program for flu, shingles and pneumonia will continue to be offered so that retirees get the necessary preventive medications at no cost.

## **Other Programs**

Last year, the Committee announced the addition of Silver Sneakers® Fitness Program for our Medicare eligible members. Members are able to access free or low cost gym memberships at participating facilities, senior-specific exercise classes and other ways to keep you healthy. ## **A reminder for Participants who will soon become Medicare eligible**

You must enroll in both Medicare Parts A and B to have coverage through the Trust. Please send copies of your Medicare card to the Fund Office so as not to delay your enrollment in the Medicare Advantage Plan.
