SUMMARY ANNUAL REPORT FOR
UAW ST. JOSEPH RETIREES HEALTH & WELFARE TRUST

This is a summary of the annual report of the UAW St. Joseph Retirees Health & Welfare Trust (Employer Identification Number 27-1401289, Plan Number 501) for the plan year 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has insurance contracts with Blue Cross Blue Shield of Michigan, Vision Service Plan, and Cigna Health and Life Insurance Company to pay certain health, prescription drug, vision, and dental claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$3,501,193.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$83,693,841 as of the end of plan year, compared to \$78,913,070 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$4,780,771. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$8,744,695 including gains of \$713,382 from the sale of assets, earnings from investments of \$8,023,611, and other income of \$7,702.

Plan expenses were \$3,963,924. These expenses included \$462,731 in administrative expenses, \$3,217,971 paid to insurance carriers for the provision of benefits, and \$283,222 in claims paid.
