NOTICE OF SUMMARY PLAN INFORMATION

November 15, 2025

To: Plumbers Local 98, MCA Detroit, and Contributing Employers

The Pension Protection Act of 2006 requires that multiemployer defined benefit funds provide certain information to the Union and contributing employers on an annual basis. Below please find this information for the January 1, 2024 – December 31, 2024, Plan Year (2024 Plan Year):
