How to Elect to Receive Plan Materials Electronically (e-Delivery)

As a U.A. Local No. 393 Defined Benefit Pension Plan and/or U.A. Local No. 393 Health & Welfare Plan participant, you are entitled to important material explaining how your benefits work. You have the option to receive this information electronically, and there are many good reasons to do so. **e-Delivery** is convenient, reduces paper clutter & is environmentally friendly!

e-Delivery ensures fast and free delivery of the most current Plan Notifications and Materials, allowing more of your contributions to be spent on your benefits.

Some example documents that *may* be sent to you electronically include, but are not limited to:

- Summary Plan Descriptions
- Annual Funding Notice
- Summary of Material Modifications
- Summary Annual Report
- Black Out Notices
- Summary of Benefits and Coverage
- Summary of Benefits and Coverage: Notice of Modification

e-Delivery is voluntary – if you prefer receiving plan materials via U.S. Mail, then no action is required.

e-Delivery: Electronic materials are emailed, typically in Portable Document Format (PDF), and are identical to the paper versions you've been receiving. **There is no charge for accepting materials online.** You will need an internet connection and a computer or smart phone with an operating system capable of receiving, accessing and displaying the electronic documents received. You will need a PDF reader such as Adobe Reader to access PDF files.

To opt in to receive plan materials electronically via your email address, fill out this form and return it to the address listed above. Please note, by opting in, you also consent to allowing your email address to be shared with the U.A. Local 393 Union and the Pipe Trades Training Center.
