SUMMARY ANNUAL REPORT FOR UBCJ OF AMERICA GEN. OFFICE & STAFF H&W PLAN

This is a summary of the annual report for the UBCJ OF AMERICA GEN. OFFICE & STAFF H&W PLAN, (Employer Identification No. 52-1911622, plan no. 501) for the period January 1, 2024 to December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The value of plan assets, after subtracting liabilities of the plan, was \$11,030,154 as of December 31, 2024 compared to \$10,903,879 as of January 1, 2024. During the plan year the plan experienced an increase in its net assets of \$126,275. This increase includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$5,505,841. This income included employer contributions of \$4,417,400, employee contributions of \$267,314, realized losses of \$145,504 from the sale of assets and earnings from investments of \$832,741. Plan expenses were \$5,379,566. These expenses included \$366,247 in administrative expenses and \$5,013,319 in benefits paid to participants and beneficiaries.
