Dear Participants:

The Board of Trustees are pleased to announce that effective January 1, 2026 the temporary Dental and Vision benefit has been extended. If you or your covered dependents receive eligible dental and/or vision care between January 1, 2026 and December 31, 2026, you can submit a claim form to the Administrative Office for reimbursement up to the combined dental/vision maximum benefit of \$1,500 per covered family. Enclosed, you will find the Summary of Benefits and Coverage (SBC) for the upcoming 2026 plan year. This document offers an overview of your health benefits, including deductibles, covered services, and out-of-pocket costs. There are no changes in your out-of-pocket costs from 2025.

Hinge Health provides virtual specialized virtual care for musculoskeletal issues for physical therapy and pelvic floor therapy.
