SUMMARY ANNUAL REPORT

FOR EAST BAY RESTAURANT & TAVERN RETIREMENT PLAN

This is a summary of the annual report for the East Bay Restaurant & Tavern Retirement Plan, E.I.N. 94-6076428, Plan No. 001, for the year ended December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$1,926,264. These expenses included \$419,284 in administrative expenses and \$1,506,980 in benefits paid to or for participants and beneficiaries. A total of 4,649 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$35,733,053 as of December 31, 2024, compared to \$31,673,043 as of January 1, 2024. The plan experienced an increase in its net assets of \$4,060,010. This increase includes unrealized appreciation/depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had a total income of \$5,986,274 including employer contributions of \$2,248,677, dividend and interest income of \$569,691, net appreciation in fair value of investments including realized and unrealized gains/losses of \$3,147,015 and other income of \$20,891.

4. transactions in excess of 5% of the plan assets.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (7180 Koll Center Parkway, Suite 200, Pleasanton, CA 94566) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
