Dear Member or Beneficiary:

Since issuance of the January 1, 2021, Summary Plan Description, some of the factual information in the SPD has changed. These changes are described below, with reference to the affected SPD sections and pages. Please keep this notice with your SPD.

**SECTION 15—BENEFIT CLAIMS PROCEDURE—(C) Review of Denied Claim—**  
**(3) Time Period to Request Review (SPD pages 14 and 15).** The Department of Labor issued guidance that clarifies the COVID-19-related extension of the deadline to file a claim appeal will not exceed one year. Therefore, the last sentence of Section 15(C)(3) is revised to read as follows:

“However, when calculating the time limit to request review, the Plan will disregard the period of March 1, 2020, until the earlier of (a) one year from the original due date, and (b) 60 days after the announced end of the national emergency due to COVID-19.”

**SECTION 16—ADMINISTRATION (SPD pages 15 and 16).** The Plan was amended such that the Pacific Printing Industries Association ceased all involvement with the Plan effective July 21, 2021, the date the Association dissolved. To reflect that change, Section 16’s first four paragraphs are replaced with the following:

“The Board of Trustees is the plan sponsor and administrator of the Plan and Trust Fund and has the responsibility for preserving the Fund and safeguarding the rights of the members under the provisions of the Plan. The Board of Trustees’ application for an employer identification number is currently pending with the Internal Revenue Service. (The employer identification number for the prior plan sponsor, Pacific Printing Industries Association, was 93-0887396.) The Plan number is 001.

“BeneSys, Inc., a contract administrator, has been appointed to assist the Board of Trustees with the administration of the Plan. The Trustee is Jules VanSant. The Board of Trustees and the Trustee can be contacted through the contract administrator (also referred to as the “Administrative Office”) at the following address:

“The Board of Trustees is the agent for service of legal process, and process may be served on it at its address, provided immediately above. Service also may be made on the Trustee at that address.”

**SECTION 17—Plan Documents (SPD pages 16 and 17).** To reflect that the Pacific Printing Industries Association ceased involvement with the Plan effective July 21, 2021, the reference to the Association is deleted from the first sentence of Section 17's second paragraph. That sentence now reads as follows: “The Board of Trustees has reserved the right to amend the Plan from time to time.”

**SECTION 19—Plan Insurance Information (SPD pages 17 and 18).** To reflect that the Pacific Printing Industries Association ceased involvement with the Plan effective July 21, 2021, “Administrative Office” is substituted for “Association” in Section 19's last paragraph.

**SECTION 20—Statement of ERISA Rights (SPD page 18).** To reflect that the Pacific Printing Industries Association ceased involvement with the Plan effective July 21, 2021, “Administrative Office” is substituted for “Association” in Section 20(B).
