

**SUMMARY ANNUAL REPORT**

This is a summary of the annual report of the San Francisco Culinary, Bartenders and Service Employees Legal Services Trust Fund (the "Plan"), E.I.N. 94-6625180, Plan No. 501, for the year ended March 31, 2025. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$7,591,485 as of March 31, 2025, compared to \$6,842,513 as of March 31, 2024. During the plan year, the plan experienced an increase in its net assets of \$748,972. This increase includes unrealized appreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$2,290,944 including employer contributions of \$1,883,189, dividend and interest income of \$326,899, and net appreciation in fair value of plan investments of \$80,856.

Plan expenses were \$1,541,972. These expenses included \$399,925 in administrative expenses and \$1,142,047 in benefits paid to or for participants and beneficiaries.

2. financial information and information on payments to service providers;
3. assets held for investment; and
4. transactions in excess of 5% of plan assets.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (7180 Koll Center Parkway, Suite 200, Pleasanton, CA 94566) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
