

SUMMARY ANNUAL REPORT
FOR SAN FRANCISCO CULINARY, BARTENDERS AND SERVICE
EMPLOYEES WELFARE FUND

This is a summary of the annual report of the San Francisco Culinary, Bartenders and Service Employees Welfare Fund, E.I.N. 94-1645611, Plan No. 501, for the year ended March 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, United Healthcare, Vision Service Plan, Blue Shield of California, Chinese Community Health Plan, and Health Net to provide medical, dental, and vision benefits under terms of the plan. The total premiums paid for the plan year ended March 31, 2024 were \$134,116,072.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$86,890,123 as of March 31, 2024, compared to \$52,917,400 as of March 31, 2023. During the plan year, the plan experienced an increase in its net assets of \$33,972,723. This increase includes unrealized appreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$178,929,583 including employer contributions of \$173,438,169, participant contributions of \$380,350, other contributions of \$865,352, dividend and interest income of \$2,265,730, and net appreciation in fair value of plan investments of \$1,979,982.

Plan expenses were \$144,956,860. These expenses included \$2,860,544 in administrative expenses, \$125,914,008 in premium payments and \$16,182,308 in benefits paid to or for participants and beneficiaries.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An independent auditor's report;
2. financial information and information on payments to service providers;
3. assets held for investment;
4. transactions in excess of 5% of plan assets, and
5. insurance information, including sales commissions paid by insurance carriers.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
