Important information about your investment lineup

DATE: May 20, 2017

As a participant in the Sheet Metal Workers Local 292 Annuity Plan, you deserve a retirement plan that is well equipped to help you pursue your long-term financial goals. The Board of Trustees recently reviewed the investment options offered through the Plan and, upon the recommendation of the Fund's Investment Consultant, decided to make the following change, effective June 20, 2017:

- The ClearBridge Small Cap Growth Fund A (SASMX) will be removed from the Plan's investment line-up and from any applicable Model Portfolios and replaced with the Janus Triton Fund A (JGMAX).

What if I am currently invested in ClearBridge Small Cap Growth Fund?

If you have an existing balance in or future contributions directed to the ClearBridge Small Cap Growth Fund, your balance and future contributions will automatically be merged into Janus Triton as outlined below:

If you do not want your balance and/or future contributions transferred as outlined above, you must make your investment change(s) prior to 11:00 a.m. Eastern Time on June 19, 2017.

What are the objectives of the new funds?

The Janus Triton fund seeks long-term growth of capital. The fund pursues its investment objective by investing primarily in common stocks selected for their growth potential. In pursuing that objective, it invests in equity securities of small- and medium-sized companies. The fund may also invest in foreign securities, which may include investments in emerging markets.

What are the fees for the new funds and the funds they are replacing?

The fee for the Janus Triton is 1.17% (117 basis points). The fee for the ClearBridge Small Cap Fund was 1.24% (124 basis points).

Why is the change taking place?

The Clearbridge Small Cap Fund has underperformed its style-correlated benchmark, and the Board, upon the recommendation of its Investment Consultant, has selected the replacement options based on cost, composition and return history.

Investment Restrictions

In addition to any restrictions imposed by the plan, the following restrictions are imposed by the plan investment alternative.

AMERICAN CENTURY MID CAP VALUE A

Maximum of 1 round trip allowed per 7 days period. Maximum of 1 round trip allowed per 30 days period.

CLEARBRIDGE SMALL CAP GROWTH FUND A

A round trip is defined as a buy and sell that occur within 30 days. Under the fund's policies and procedures, the fund reserves the right to restrict or reject purchases of shares (including exchanges) without prior notice whenever a pattern of excessive trading by a shareholder is detected in funds sold by the distributor. A committee established by the manager administers the policy. The policy provides that the committee may take action, which may include using its best efforts to restrict a shareholder's trading privileges in funds sold by the distributor, if that shareholder has engaged in one or more "Round Trips" across all funds sold by the distributor.

COLUMBIA OVERSEAS VALUE A

The Fund takes various steps designed to detect and prevent excessive trading, including daily review of available shareholder transaction information. However, the Fund receives buy, sell or exchange orders through selling agents, and cannot always know of or reasonably detect excessive trading that may be facilitated by selling agents or by the use of the omnibus account arrangements they offer. Omnibus account arrangements are common forms of holding shares of mutual funds, particularly among certain selling agents such as broker-dealers, retirement plans and variable insurance products. These arrangements often permit selling agents to aggregate their clients' transactions and accounts, and in these circumstances, the identity of the shareholders is often not known to the Fund.

GOLDMAN SACHS SMALL CAP VALUE CLASS A

Maximum of 1 round trip allowed per 90 days period.

JANUS ENTERPRISE FD CLASS A

A round trip is defined as a buy and sell that occur within 90 days. Maximum of 1 round trip allowed per 90 days period.

JANUS TRITON A

A round trip is defined as a buy and sell that occur within 90 days. Maximum of 1 round trip allowed per 90 days period.

MFS VALUE CLASS A

The MFS funds reserve the right to restrict, reject, or cancel, without any prior notice, any purchase or exchange order, including transactions believed to represent frequent or other disruptive trading activity. MFSC will generally restrict, reject or cancel purchase and exchange orders into the fund if MFSC determines that an account holder has made two exchanges, each in an amount of \$15,000 or more, out of an account in the fund during a calendar quarter ("two exchange limit").

PRUDENTIAL JENNISON GROWTH FUND A

Excessive trading violation will result in a trading restriction period of 60 days. Maximum of 1 round trip allowed per 30 days period.
